- (ii) With five years' service in the Stenographer's cadre rendered after appointment thereto on a regular basis in Level-6, Rs.35400-112400/- or equivalent in the parent cadre or Department.

Period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or Department of the Central Government shall ordinarily not exceed three years.
